The district publicly advertised for 20 days (December 16, 2020-January 8, 2021) a Request for Proposal (RFP) # CBOE 29-20 for Parent Linking Program and opened on January 12, 2021. The District opened and received one (1) proposal at 10 a.m. that was recorded on a zoom live meeting, which the link was sent out to only those who requested it.

The evaluation committee evaluated the proposal based off of the award criteria listed in the RFP packet and it was deemed that Camden Center for Youth Development, Inc. has met the criteria.

Camden Center for Youth Development will provide and facilitate, but not limited to the following:

- Employment of (5) FTE Mental Health Practitioners; (2) FTE Youth Development Specialists; (1) Team Liaison; (1) Consultant Head Teacher and (3) Primary Caregivers to achieve the following outcome with SBYSP referred students: Improved behavioral stability; improved emotional well-being; improved educational performance and improved school attendance
- Assuming financial responsibility for contracted employees
- Professional development relative to adolescent development, positive youth development, teen parenting and early childhood development
- Monitoring contractual staff's attendance and employment records
- Facilitate the hiring of contractual staff; as approved by the SBYSP Project Manager
- Submit monthly expenditure reports and invoices for reimbursement to SBYSP Project Manager

The term of the contract shall be from January 2021 through June 30, 2021.

The Office of Information Technology is requesting an amendment to Resolution #199 SY20-21 approved in the December 2020 board meeting. The Office of Information Technology is requesting authorization to re-renew the services with Crown Castle Fiber for Internet/Wan access and infrastructure for a 6 months and increase the cost not to exceed from \$400,000.00 to \$800,000.00. The service was originally implemented in school year 2014-2015 and renewed in 2019 on Resolution #210 SY18-19. Crown Castle has been bought out by Lighttower, where we originally used State contract, T1776. We were able to extend the contract up to 7 years using the exception: 18A-42.d- Data processing service or the 42.n- Purchase made under a contract awarded by the Director of the Division of Purchase and Property. The previous contract expired January 1, 2021. The second term renewal contract would run January 1, 2021 to June 30, 2021. The expense of this service will be at least 80% refunded by USAC's ERate program In an amount not to exceed \$800,000.00
