<u>University of Arizona and Rutgers' University Study (Ratification)</u>

It is recommended that the Camden City School District collaborate with Rutgers University and University of Arizona on a Study of the Impact of School Closures on Students' Weight Status - October, 2020 through June 2022.

The project, funded by NIH, studies the impact of prolonged school closures associated with COVID-19 on weight status of students and the mitigating potential of emergency food programs. The research promises a unique understanding of the long-term effects of federal school meals programs serving thirty million children nationally. Findings will inform strategies to assure the adequacy of the food safety net in schools and communities in New Jersey and across the country.

Building on eight years of collaboration with the Camden public schools – as well as those in Trenton, Newark, and New Brunswick, the new study will collect the same data as previously from these schools, twice over the next four years: 1) De-identified (anonymous) nurse-measured heights and weights data, which nurses already collect, as mandated by NJ Administrative code on students attending each school; and 2) a self-administered questionnaire on the school's physical activity and food environment completed by school nurses. These data will be complemented by publicly available information on retail food outlets and physical activity opportunities in neighborhoods surrounding schools and the operation and reach of the two federal, child-targeted food assistance programs initiated during the pandemic (extension of the summer meals program and Pandemic EBT food assistance).

Data collection will be scheduled for when it is safe for school nurses to weigh and measure children. As in the past, study resources will be expended to minimize any burden on nurses associated with their collaboration on the study. Funds will support assistance to nurses in recording de-identified height and weight measurements, and personal protective equipment (PPE) will be provided. The study has been approved by the Institutional Review Boards (IRBs) of Rutgers University and Arizona State University, and the IRB protocol was reviewed by the National Institutes of Health (NIH). Data will be collected through June 2022. There is no cost to the board.
