Purpose: The Camden Coalition of Healthcare Providers along with the Campbell's Soup Healthy Communities Initiative seeks to build a city-wide BMI database of Camden residents. Collection of this data is in service of Campbell's goal to understand the problem of obesity in Camden and develop strategies to address this problem, as well as measure the impact of Healthy Communities interventions at partner sites across the city.

Methodology: With funding from Campbell's Soup Healthy Communities Initiative, the Camden Coalition of Healthcare Providers will annually collect age, gender, height and weight data from partners across the city of Camden to create a BMI surveillance system to track obesity across the city. BMI data from the hospitals will be collected individually with personal identifiers, but reported out in aggregate. BMI data from the other partners will be collected without personal identifiers.

2014-2015 Academic Year BMI data from Campbell Sites; Hatch, Wilson, and Cooper's Poynt Schools. This includes; (BMI data including a unique ID number for each student that can follow them over the next 2 years, gender, age, height, weight, and BMI).

2014-2015 Academic year raw BMI data without ID numbers from the rest the of district schools including; gender, age, height, weight, and BMI.

2011-12, 2012-13, and 2013-14 academic year BMI data, no ID numbers needed. This information includes; gender, age, height, weight and BMI. BMI data from partners in this project will be reported out in aggregate only (i.e. with no personal identifiers). Reports and analysis will be provided to project partners.
