

Urban Hope Update and Next Steps

"Although NJ's per pupil public school expenditures are among the highest in the nation, many of the State's students are failing to achieve the core curriculum content standards."

"Many students are confined to a number of persistently failing districts and schools that, year after year, have been unable to convert increased State aid and other resources into improved student achievement, higher graduation rates, or grater student readiness for postsecondary education and gainful employment."

"A number of districts are plagued with the congruent challenge of aged facilities that provide very poor learning environments for its students."

With the vast majority of schools struggling to achieve at the most basic levels academically, a graduation rate of approximately 50%, and over half of our school buildings constructed prior to World War II – Camden is in dire need of any and all meaningful solutions to improve student learning environments and better prepare students for success.

In 2012, the legislature enacted the "Urban Hope Act" (N.J.S.A. 18A:36C) to empower the school districts of Camden, Newark, and Trenton to partner with experienced nonprofit organizations to open high quality Renaissance school projects.

A Renaissance school project is defined as a "newly constructed school, or group of schools in an urban campus area, that provides an educational program for students enrolled in grades pre-K through 12 or in a grade range less than Pre-K through 12, that is agreed to by the school district, and is operated and managed by a nonprofit entity in a renaissance school district"

Renaissance school projects are operated and managed by a non-profit organization, but are approved by the local school district and Commissioner of Education. To date, Camden has approved on project, and may approve up to three more by January 2015.

"Urban Hope Act" – RFP Review

- □ 7 Applications received as part of the initial UHA RFP
- A team of 5 district administrators and 2 Board of Education members reviewed all 7 applications and scored them independently
- □ Scores were given based upon the following categories:
 - ✓ Experience
 - ✓ Track Record of Success
 - ✓ Financial Stability
 - ✓ Growth Potential
 - Community Engagement and Additional Supports

Of the 7 applicants who applied, the committee recommended that Mastery Schools and Uncommon Schools warranted additional community feedback and consideration




