Provided Technology Device Acknowledgement Form

The Camden City School District is excited to offer your child a school district provided technology device as part of their educational programming. Please review the below provisions of this program as well as the attached applicable Board of Education Policies.

- When using the district-provided technology device, students must comply with the District's Internet Safety and Technology Policy (6142.10) and Use of District Technology Devices Policy (3515.2). A copy of these policies are available on our website. Please review the policies.
- The district-provided technology device is, at all times, property of the District. The device and peripherals, loaned to a student, must be returned to the District in the condition they were initially provided to the student considering reasonable use and care by the student while they are a student in a District school. The District reserves the right to demand return of the device/peripherals at any time. Failure to return the device/peripherals may result in disciplinary action and/or criminal charges sought against the student and/or the person in possession of the device/peripherals.
- The parent or student shall be responsible to reimburse the District the replacement cost of any technology device or its associated peripherals that are lost, damaged beyond reasonable use or beyond its value, abandoned, missing, stolen, or cannot be returned to the District. A student shall report to his or her school leader within two school days in the event the technology device has been damaged or is missing.
- A student shall report any hardware or software problems in the operation of the device to Mindshift Support Services at 833-778-0035, within two school days of the commencement of the problem.
- A student shall be required to provide routine cleaning and care of the device in accordance with school district cleaning and care guidelines.

Internet and Network Use – Terms and Conditions

For those students accepting a district-provided mobile hotspot device, please be advised that you are responsible for good behavior on school computer networks and accounts the same as you are on school grounds; general school rules for behavior and communications apply. Network storage areas as well as Google Drive will be treated similar to school lockers; network administrators may review files and communications to maintain system integrity and ensure that students are using the system responsibly. Students are advised to never access, keep, or send material that they would not want their parents, teachers, or peers to see.

New Jersey's Anti-Big Brother Act Notice

The electronic device provided by the Camden City School District may record or collect information on a student's activity or a student's use of the device. The Camden City School District will not use any of these electronic capabilities in a manner that would violate the privacy rights of the student or any individual residing with the student. The District may remotely activate a location tracking feature and/or the device's on board camera should the device be reported stolen or missing.

By accepting the technology devices, I understand and agree to the terms set forth in this acknowledgement form, Camden City Board of Education Policy 6142.10 (Internet Safety and Technology Policy) and Policy 3515.2 (Use of District Technology Devices).

Student Acceptable Use Policy

An Acceptable Use Policy (AUP) is a contract signed by parents and students. This AUP is a comprehensive summary of Camden City School District's policy number 6142.10 as cited in the Policy Manual. It is important that students and parents be fully aware of their responsibilities when using Camden City School District Network and technological resources. Student expectations for use of technology in the Camden City School District are as follows:

- Students shall access the system only for educational, professional or career development activities.
- Students shall not use the district system to engage in illegal activities that violate federal, state, or local laws and regulations.
- Students shall not access material that is profane or obscene, that advocates illegal acts, or that advocates violence of hate. Inadvertent access to such materials should be reported immediately to the supervising staff person.
- Students shall not engage in "hacking" or attempts to otherwise compromise system security and system files.
- Students shall not put any type of personal technology equipment and/or software on the district network without permission.
- Students shall not post personal contact information. Personal contact information includes your name, address, telephone number, school address, work address, etc.
- Students shall not deliberately attempt to disrupt the district's computer system performance or destroy data by spreading computer viruses, worms, "Trojan Horses," trap door program codes or any similar product that can damage computer systems, firewalls, servers or network systems.
- Students shall not use proxies, remote software or any other means to get around the district web filter.
- Students shall not attempt to gain unauthorized access to any district system or file without authorization. This includes attempting to log in through another individual's account or accessing another's files.
- Students shall not plagiarize material that is available on the internet. Plagiarism is presenting another's ideas/words as one's own.
- Students shall not infringe on copyrighted material and shall follow all dictates of copyright law and the acceptable policies of this district.
- Students shall not use the district computer network to activate a business, nor shall the district network be used to create a website unless permission is granted by an authorized staff member.
- Students shall manage and maintain individual district e-mail accounts if assigned.
- Students shall be mindful that e-mail is not private. It is the property of the Camden City School District.
- Students shall not send or receive messages that contain obscene, profane, lewd, vulgar, rude, and inflammatory or threatening language.
- Students shall not use the system to spread messages that can reasonably be interpreted as cyber-bullying, harassing, discriminatory or defamatory.
- Students shall not post chain letters or engage in "spamming." Spamming is sending an annoying or unnecessary message to a large number of people.
- Students shall not access the district computers to download music, movies, software, games or documents which infringes upon copyrights or licensing agreements.
- Students shall understand that if routine maintenance and monitoring leads to the discovery that a user has or is violating the district Acceptable Use Policy, The Camden City School District will cooperate fully with local, state, or federal officials in any investigation concerning or relating to any legal activities.

Students (Minors under the age of 18 - If you are under the age of 18 a parent and/or guardian must also read and sign this agreement.)

I have read and agree to comply with the Camden City School District Acceptable Use Policy. Should I commit any violation, my access privileges may be revoked and appropriate disciplinary action taken.

Póliza de Uso Aceptable del Estudiante

Una póliza de uso aceptable (AUP) es un contrato firmado por los padres y estudiantes. Esta AUP es un resumen comprensivo de la póliza número 6142.10 del distrito escolar de la ciudad de Camden, como se cita en el Manual del Gobierno. Es importante que los estudiantes y los padres estén plenamente conscientes de sus responsabilidades cuando se utilizan los recursos tecnológicos del Distrito Escolar de Camden. Las expectativas de los estudiantes para el uso de la tecnología en el distrito escolar de la ciudad de Camden son los siguientes:

- Los estudiantes deberán tener acceso al sistema sólo para actividades de desarrollo educativo, profesional o de carrera.
- Los estudiantes no deberán usar el sistema del distrito para participar en actividades ilegales que violan las leyes y reglamentos federales, estatales y locales.
- Los estudiantes no pueden acceder a material profano u obsceno, que aboga actos ilegales, o que promueva la violencia de odio. El acceso involuntario a tales materiales debe ser reportado inmediatamente al personal de supervisión.
- Los estudiantes no deben participar en la "piratería" o intentos que comprometen el sistema de seguridad y de archivos.
- Los estudiantes no deben poner ningún tipo de equipo de tecnología personal y/o programa en la red del distrito sin permiso.
- Los estudiantes no deben publicar información de contacto personal. La información personal incluye su nombre, dirección, número de teléfono, dirección de la escuela, dirección del trabajo, etc.
- Los estudiantes no deben intentar deliberadamente alterar el rendimiento del sistema informático del distrito o destruir datos mediante la difusión de virus informáticos, gusanos, "caballos de Troya", códigos de programa trampilla o cualquier producto similar que pueda dañar los sistemas informáticos, cortafuegos, servidores o sistemas de red.
- Los estudiantes no deberán usar programa remoto, substituto y/o cualquier otro medio para moverse por el filtro de la red del distrito.
- Los estudiantes no deben intentar obtener acceso a cualquier sistema del distrito o archivo sin autorización. Esto incluye intentar ingresar en la cuenta de otra persona o acceder a los archivos de otra persona.
- Los estudiantes no deben imitar material que está disponible en el Internet. La imitación es presentar ideas/palabras de otras personas como si fueran propias.
- Los estudiantes no deben infringir los derechos del autor y el material debe seguir todos los dictados de la ley de propiedad intelectual y las pólizas aceptables de este distrito.
- Los estudiantes no deben usar la red de computadoras del distrito para activar un negocio, ni se utilizará la red del distrito para crear un sitio web a menos que el permiso se conceda por un miembro del personal autorizado.
- Los estudiantes deben manejar y mantener cuentas de correo electrónicas individuales del distrito si se le ha asignado.
- Los estudiantes deben ser conscientes de que el correo electrónico no es privado. Es la propiedad del distrito escolar de la ciudad de Camden.
- Los estudiantes no deben enviar o recibir mensajes que contengan lenguaje obsceno, profano, lascivo, vulgar, grosero, y el lenguaje agresivo o amenazante.
- Los estudiantes no deben usar el sistema para difundir mensajes que pueden ser razonablemente interpretados como acoso cibernético, acoso, discriminatorio o difamatorio.
- Los estudiantes no pueden publicar mensajes en cadena o participar en "correo basura". El "spam" es el envío de un mensaje molesto o innecesario a un gran número de personas.
- Los estudiantes no deben tener acceso a las computadoras del distrito para descargar música, películas, programas, juegos o documentos que afecten a los derechos del autor o acuerdos de licencia.
- Los estudiantes deben entender que si el mantenimiento y la vigilancia rutinaria lleva al descubrimiento de que un usuario tiene o está violando la Póliza de Uso Aceptable del distrito, el distrito escolar de la ciudad de Camden cooperará completamente con los locales, estatales o federales en cualquier investigación concerniente o relacionada con las actividades legales.
